

SCOPE & APPLICABILITY

Extraterritorial

All laws apply when targeting products or services to state consumers.

The laws have thresholds so that they exclude small businesses or businesses that don't process significant amounts of personal data.



Most laws exclude data regulated by federal privacy laws such as HIPAA, GLBA, FCRA, and FERPA.



Most laws apply only to for-profit companies. But a few also apply to non-profit and educational entities.

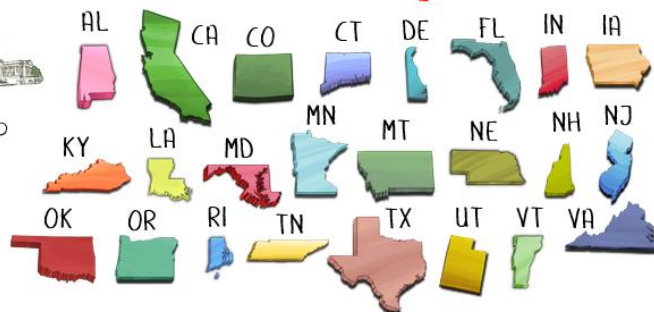

Most Laws: Require opt-in consent + data protection assessment.

Exception: A few states just require opt out

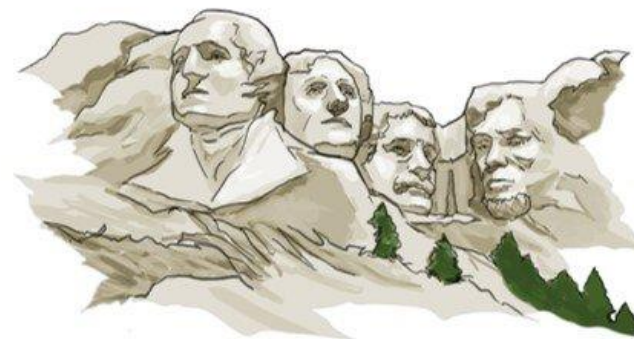
